## **2 System Test Configuration**

### **2.1 EUT Configuration**

The EUT configuration for testing is installed on RF field strength measurement to meet the Commissions requirement and operating in a manner which intends to maximize its emission characteristics in a continuous normal application.

### **2.2 EUT Exercise**

The EUT (Transmitter) was operated in the engineering mode to fix the Tx frequency that was for the purpose of the measurements.

### **2.3 Test Procedure**

#### **2.3.1 Conducted Emissions**

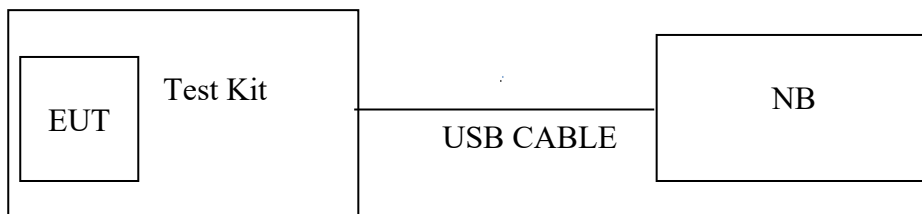
The EUT is placed on a turn table which is 0.8 m above ground plane. According to the requirements in Section 6 of ANSI C63.10: 2013 and RSS-Gen issue 5 Amendment 2: 2021. Conducted emissions from the EUT measured in the frequency range between 0.15 MHz and 30 MHz using CISPR 16-1-1 Quasi-Peak and Average detector mode.

#### **2.3.2 Radiated Emissions**

The EUT is placed on a turn table which is 0.8 m/1.5m (frequency above 1 GHz) above ground plane. The turn table shall rotate 360 degrees to determine the position of maximum emission level. EUT is set 3m away from the receiving antenna which varied from 1m to 4m to find out the highest emission. And also, each emission was to be maximized by changing the polarization of receiving antenna both horizontal and vertical. In order to find out the max. emission, the relative positions of this hand-held transmitter(EUT) was rotated through three orthogonal axes according to the requirements in Section 6 and 11 of ANSI C63.10: 2013.

### 4 Description of Test Modes

The EUT has been tested under engineering operating condition.

Test program used to control the EUT for staying in continuous transmitting mode is programmed.

BLE 5.1 mode: Channel low (2402MHz), mid (2442MHz) and high (2480MHz) with data rate 1Mbps are chosen for full testing since the conducted power is greater than BLE 4.0 mode.

## 5 Conducted Emission Test

### 5.1 Standard Applicable:

According to §15.207 and RSS-Gen §8.8, frequency range within 150kHz to 30MHz shall not exceed the Limit table as below.

### 5.3 EUT Setup:

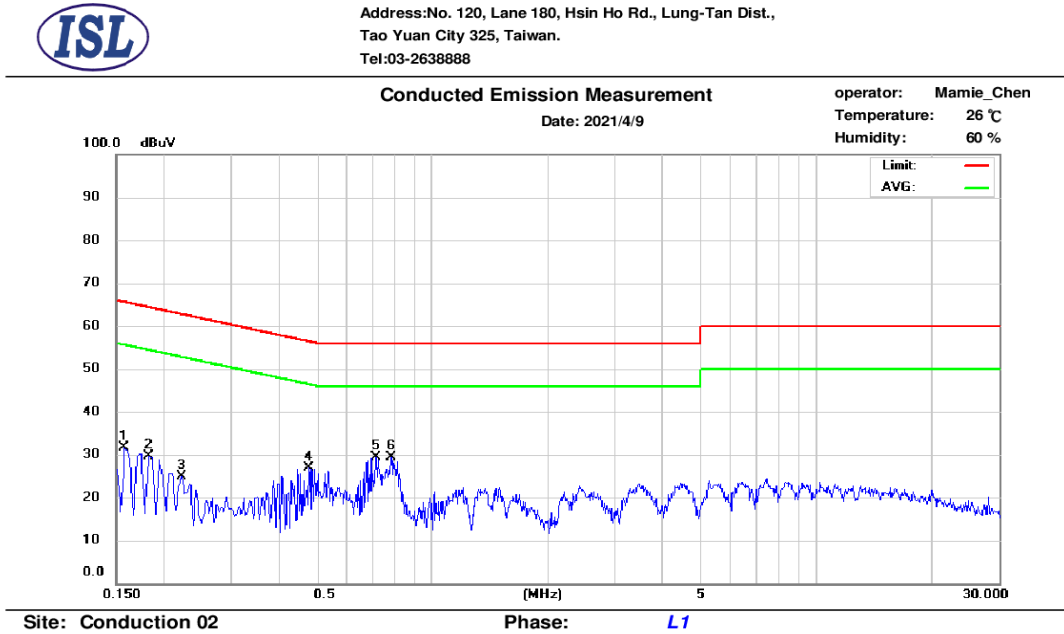
1. The conducted emission tests were performed in the test site, using the setup in accordance with the ANSI C63.10-2013.
2. The AC/DC Power adaptor of PC was plug-in LISN. The EUT was placed flushed with the rear of the table.
3. The LISN was connected with 120Vac/60Hz power source.

### 5.4 Measurement Procedure:

1. The EUT was placed on a table which is 0.8m above ground plane.
2. Maximum procedure was performed on the six highest emissions to ensure EUT compliance.
3. Repeat above procedures until all frequency measured were complete.

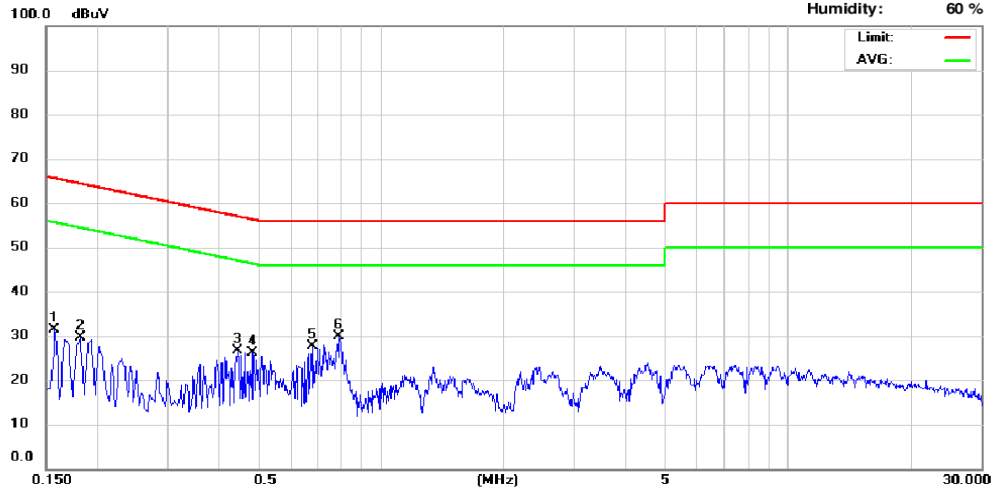

## 6 Peak Output Power Measurement

### 6.1 Standard Applicable:

According to §15.247(b)(3), (b)(4), (c)

(3) For systems using digital modulation in the 902-928 MHz, 2400-2483.5 MHz, and 5725-5850 MHz bands: 1 Watt. As an alternative to a peak power measurement, compliance with the one Watt limit can be based on a measurement of the maximum conducted output power. Maximum Conducted Output Power is defined as the total transmit power delivered to all antennas and antenna elements averaged across all symbols in the signaling alphabet when the transmitter is operating at its maximum power control level. Power must be summed across all antennas and antenna elements. The average must not include any time intervals during which the transmitter is off or is transmitting at a reduced power level. If multiple modes of operation are possible (e.g., alternative modulation methods), the maximum conducted output power is the highest total transmit power occurring in any mode.

(4) The conducted output power limit specified in paragraph (b) of this section is based on the use of antennas with directional gains that do not exceed 6 dBi. Except as shown in paragraph (c) of this section, if transmitting antennas of directional gain greater than 6 dBi are used, the conducted output power from the intentional radiator shall be reduced below the stated values in paragraphs (b)(1), (b)(2), and (b)(3) of this section, as appropriate, by the amount in dB that the directional gain of the antenna exceeds 6 dBi.

(c) Operation with directional antenna gains greater than 6 dBi.

(1) Fixed point-to-point operation:

(i) Systems operating in the 2400-2483.5 MHz band that are used exclusively for fixed, point-to-point operations may employ transmitting antennas with directional gain greater than 6 dBi provided the maximum conducted output power of the intentional radiator is reduced by 1 dB for every 3 dB that the directional gain of the antenna exceeds 6 dBi.

(ii) Systems operating in the 5725-5850 MHz band that are used exclusively for fixed, point-to-point operations may employ transmitting antennas with directional gain greater than 6 dBi without any corresponding reduction in transmitter conducted output power.

According to RSS-247 issue 2, §5.4

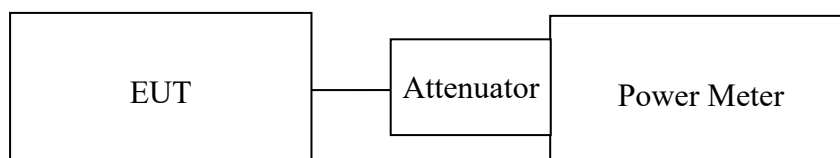
(d) For DTSs employing digital modulation techniques operating in the bands 902-928 MHz and 2400-2483.5 MHz, the maximum peak conducted output power shall not exceed 1 W. Except as provided in Section 5.4(5), the e.i.r.p. shall not exceed 4 W.

As an alternative to a peak power measurement, compliance can be based on a measurement of the maximum conducted output power. The maximum conducted output power is the total transmit power delivered to all antennas and antenna elements, averaged across all symbols in the signalling alphabet when the transmitter is operating at its maximum power control level. Power must be summed across all antennas and antenna elements. The average must not include any time intervals during which the transmitter is off or transmitting at a reduced power level. If multiple modes of operation are implemented, the maximum conducted output power is the highest total transmit power occurring in any mode.

## **7 6dB Bandwidth & 99% Bandwidth**

### **7.1 Standard Applicable:**

According to §15.247(a)(2), Systems using digital modulation techniques may operate in the 902 - 928 MHz, 2400 - 2483.5 MHz, and 5725 - 5850 MHz bands. The minimum 6 dB bandwidth shall be at least 500kHz.

According to RSS-247 issue 2, §5.2

(1) The minimum 6 dB bandwidth shall be 500 kHz.

### **7.4 Measurement Procedure:**

1. Place the EUT on the table and set it in transmitting mode.
2. Remove the antenna from the EUT and then connect a low loss RF cable from the antenna port to the spectrum analyzer.
3. Set the spectrum analyzer as RBW=100kHz, VBW = 3\*RBW, Span= cover the complete power envelope of the signal of the UUT Sweep=auto
4. Mark the peak frequency and -6dB (upper and lower) frequency.
5. Repeat above procedures until all frequency measured were complete.

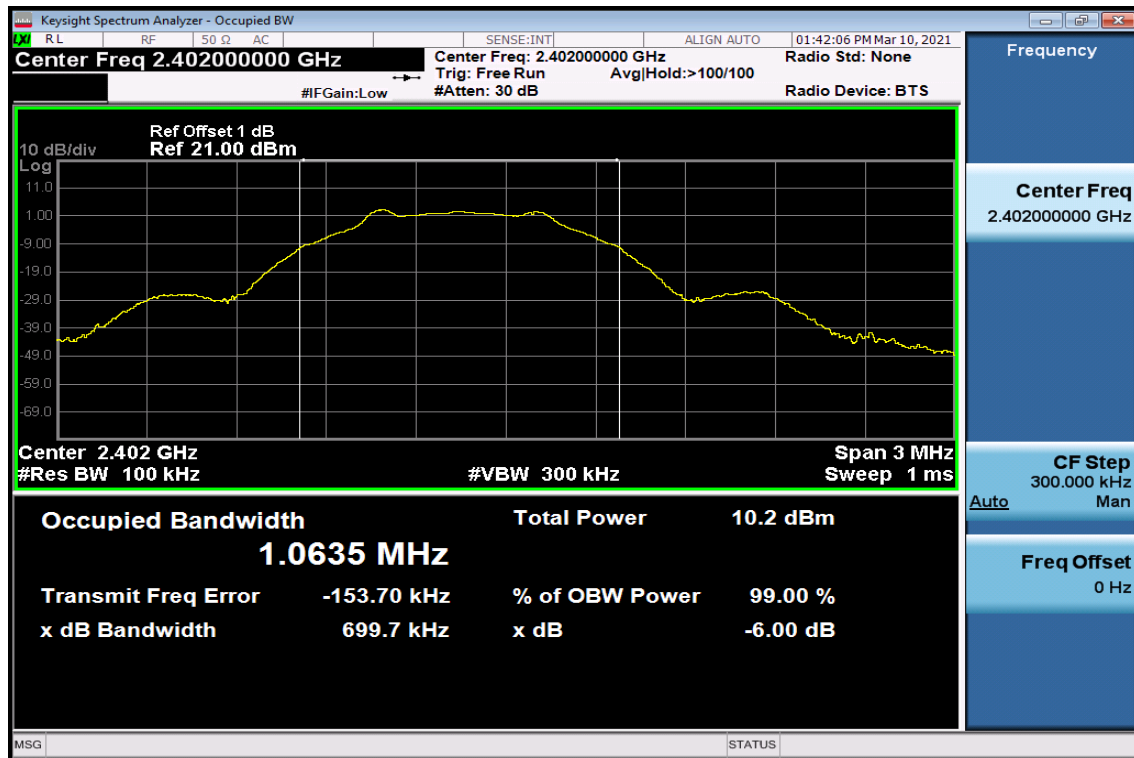

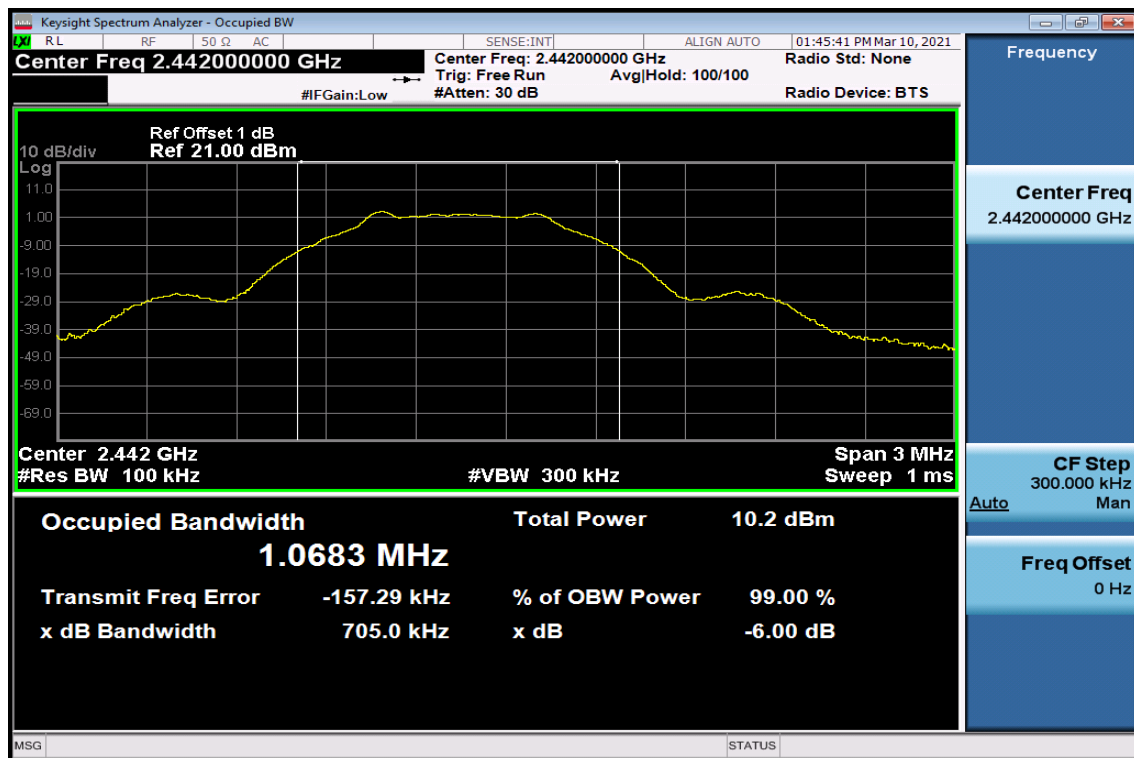

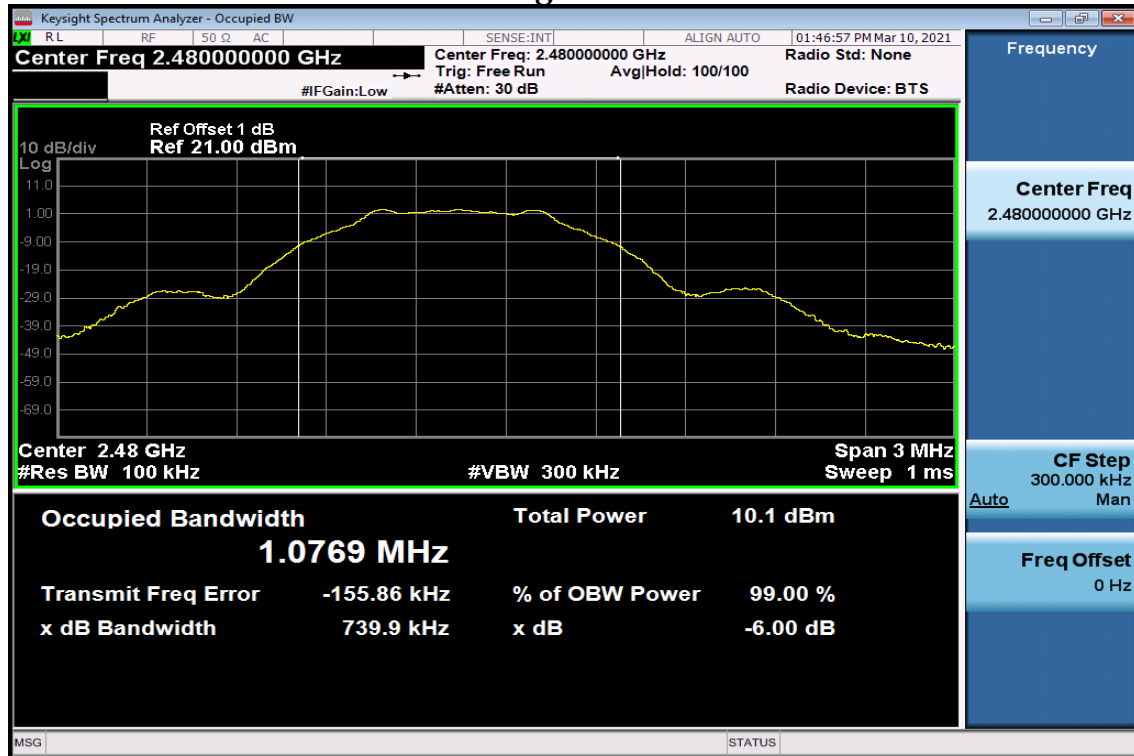
### 6dB Bandwidth Test Data CH-Low



### 6dB Band Width Test Data CH-Mid

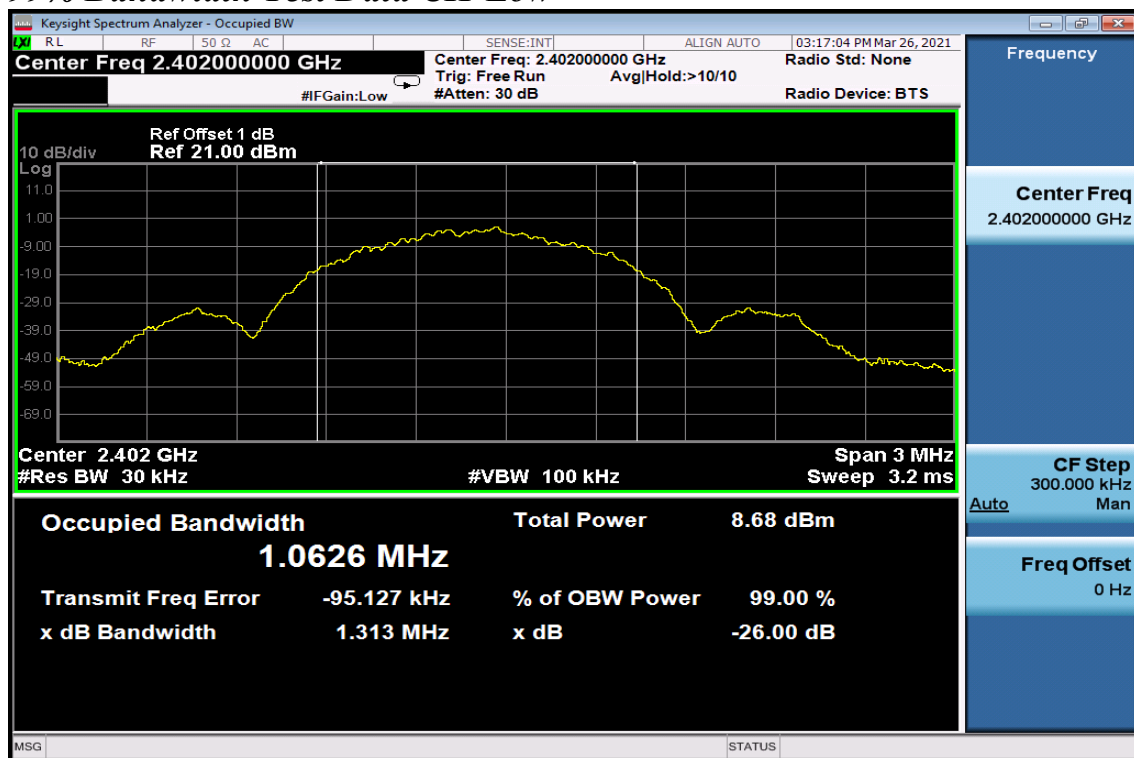


### 6dB Band Width Test Data CH-High

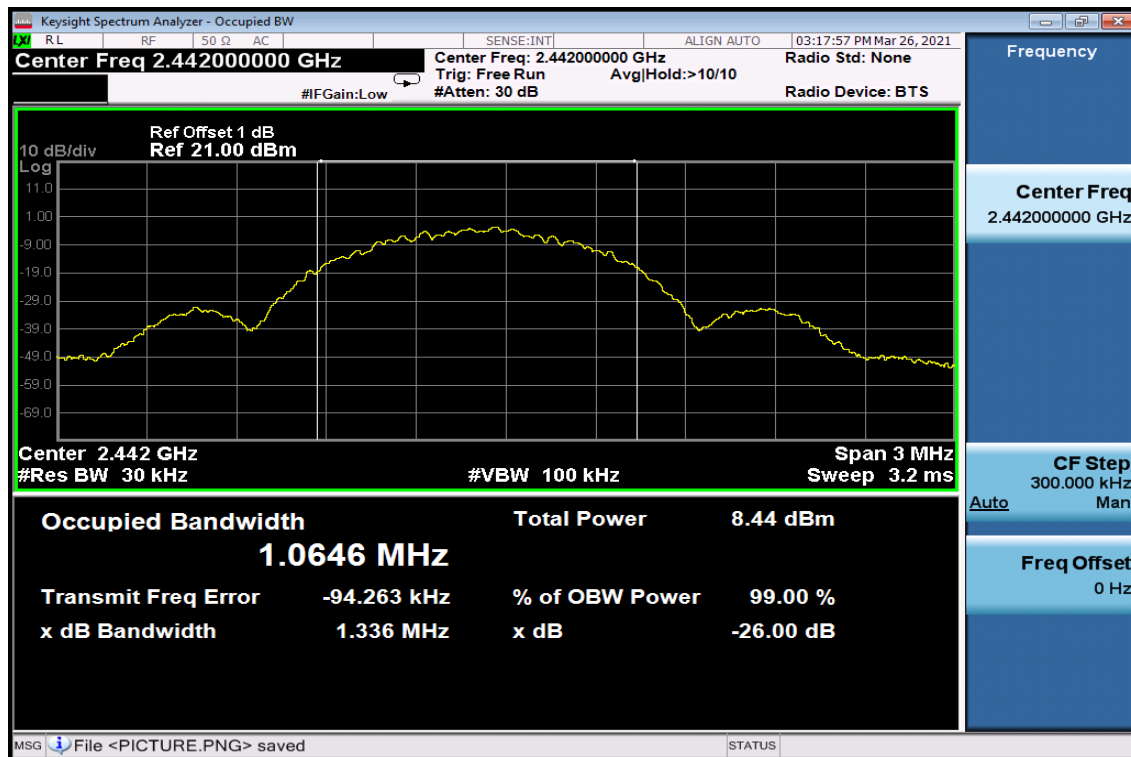

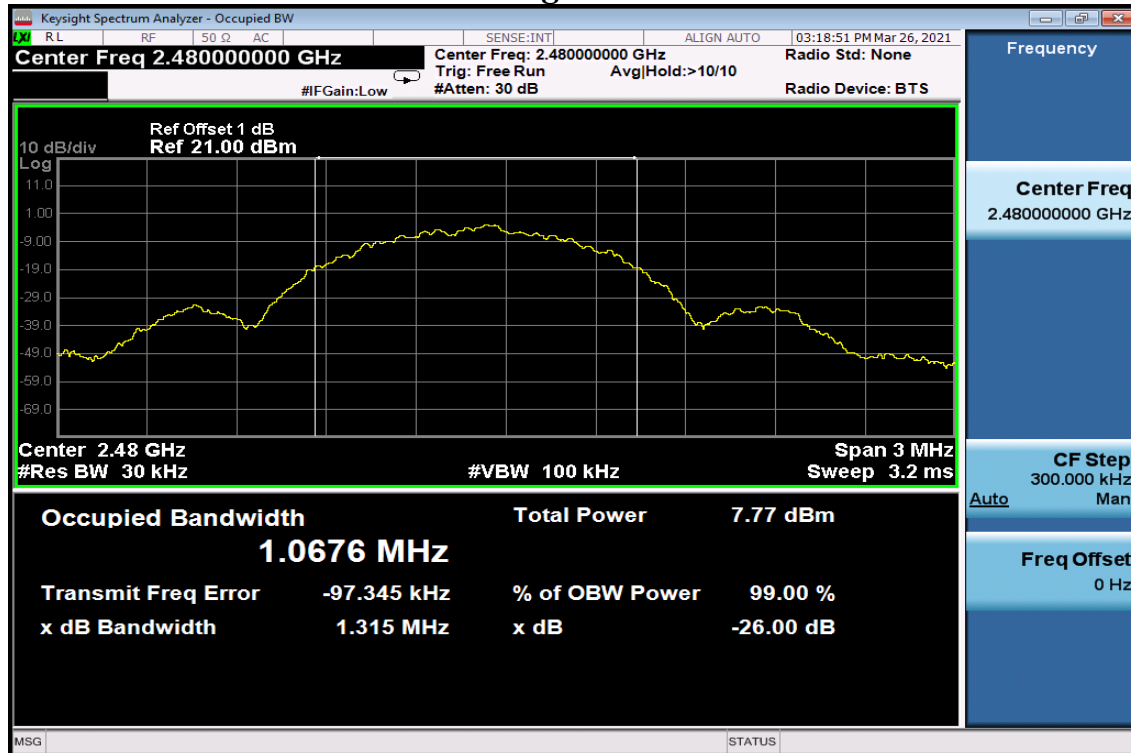
### 99% Bandwidth Test Data CH-Low



### 99% Band Width Test Data CH-Mid

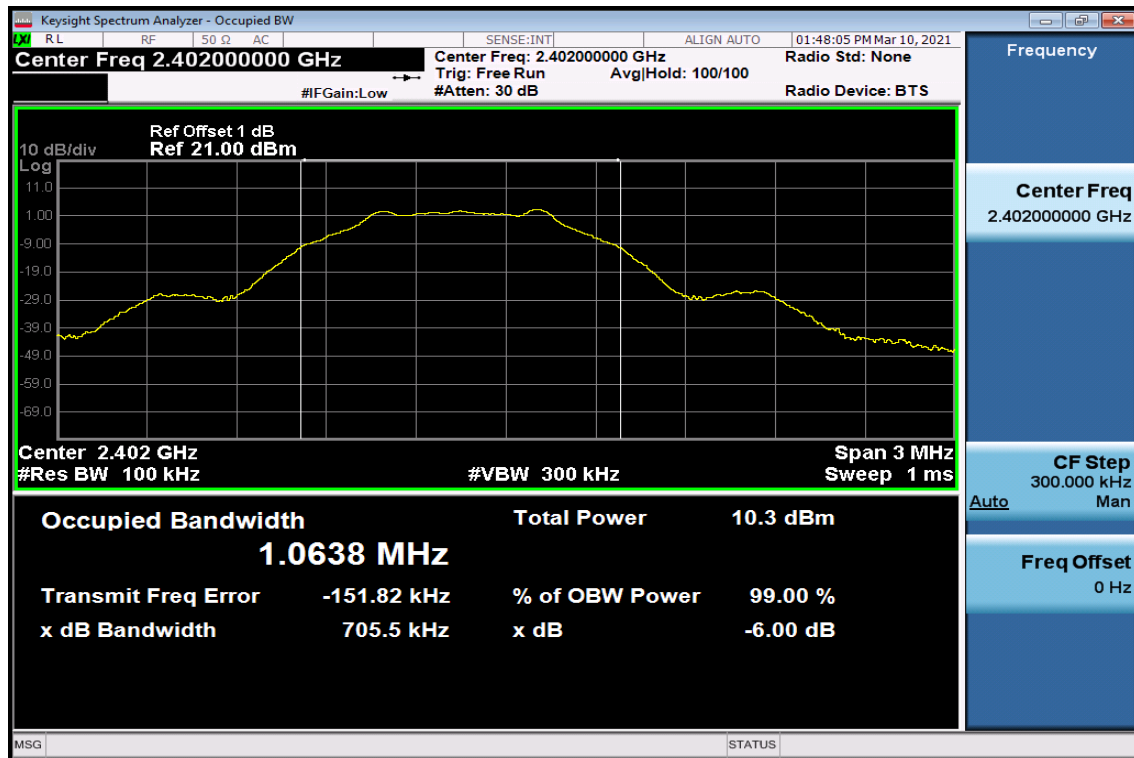


### 99% Band Width Test Data CH-High

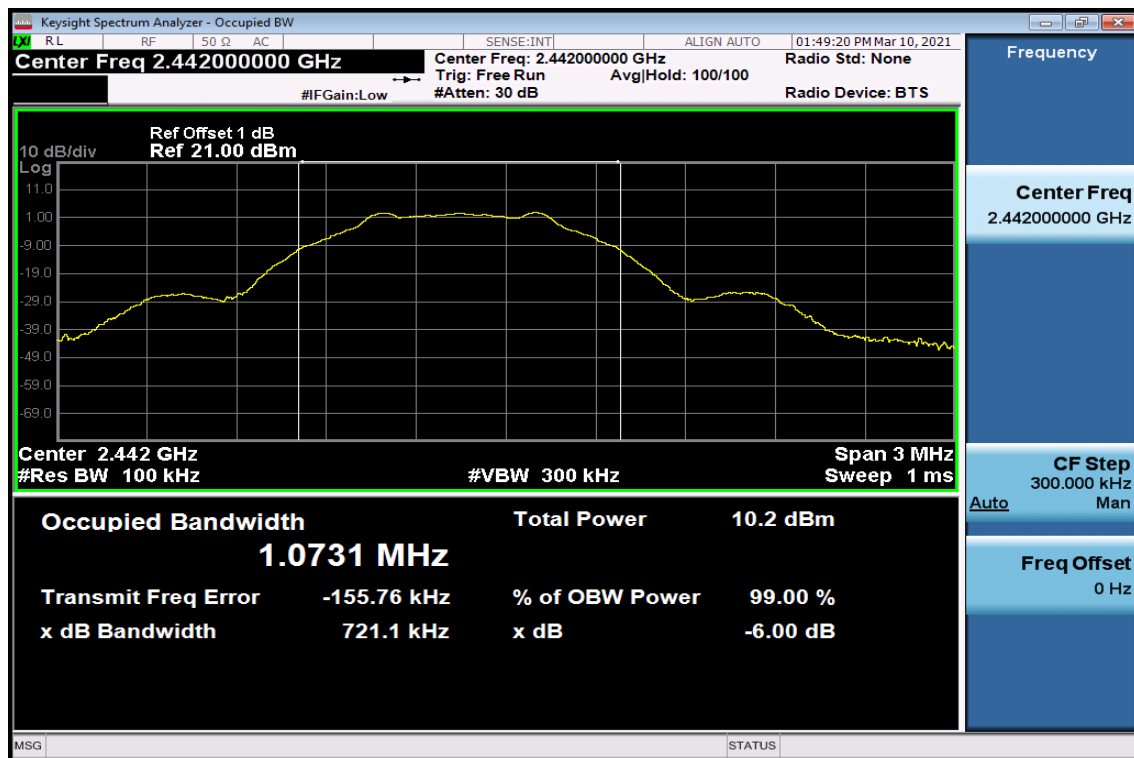

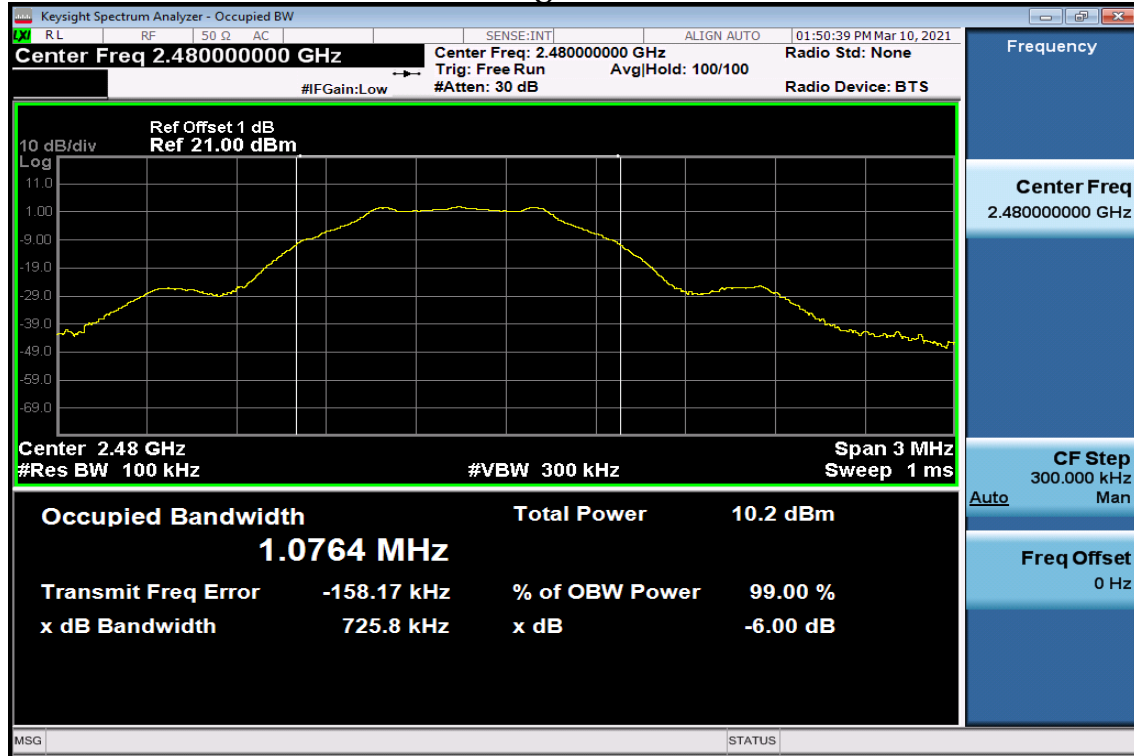
### 6dB Bandwidth Test Data CH-Low



### 6dB Band Width Test Data CH-Mid

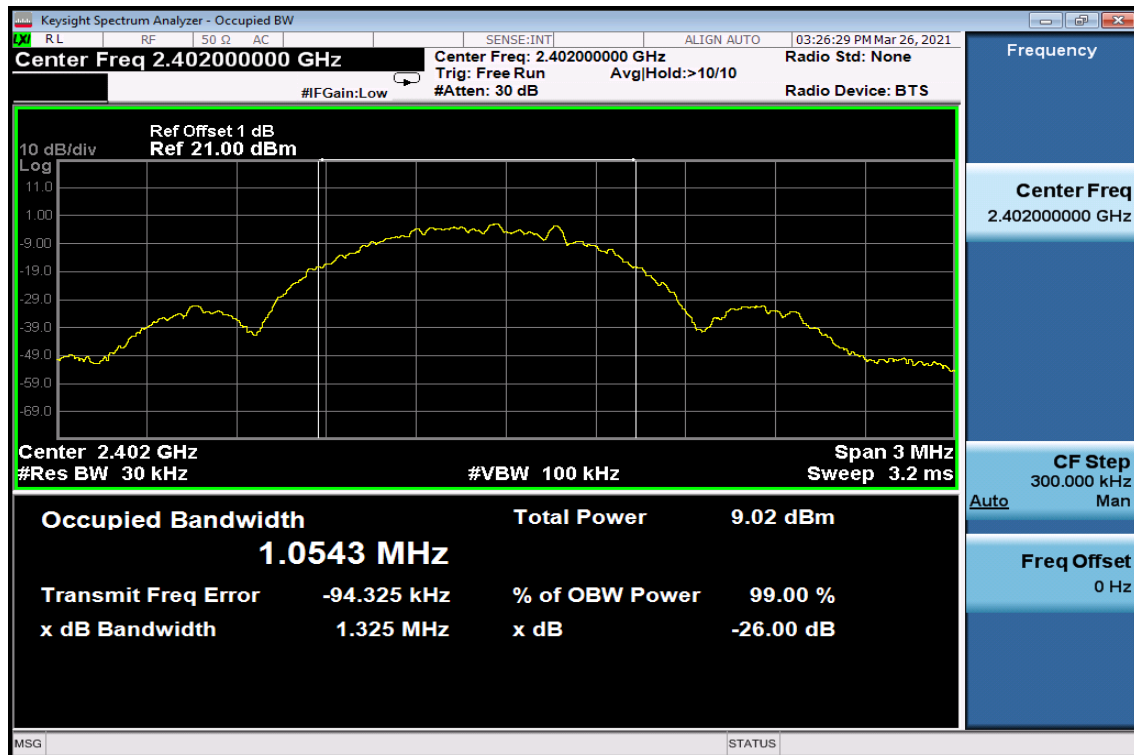


### 6dB Band Width Test Data CH-High



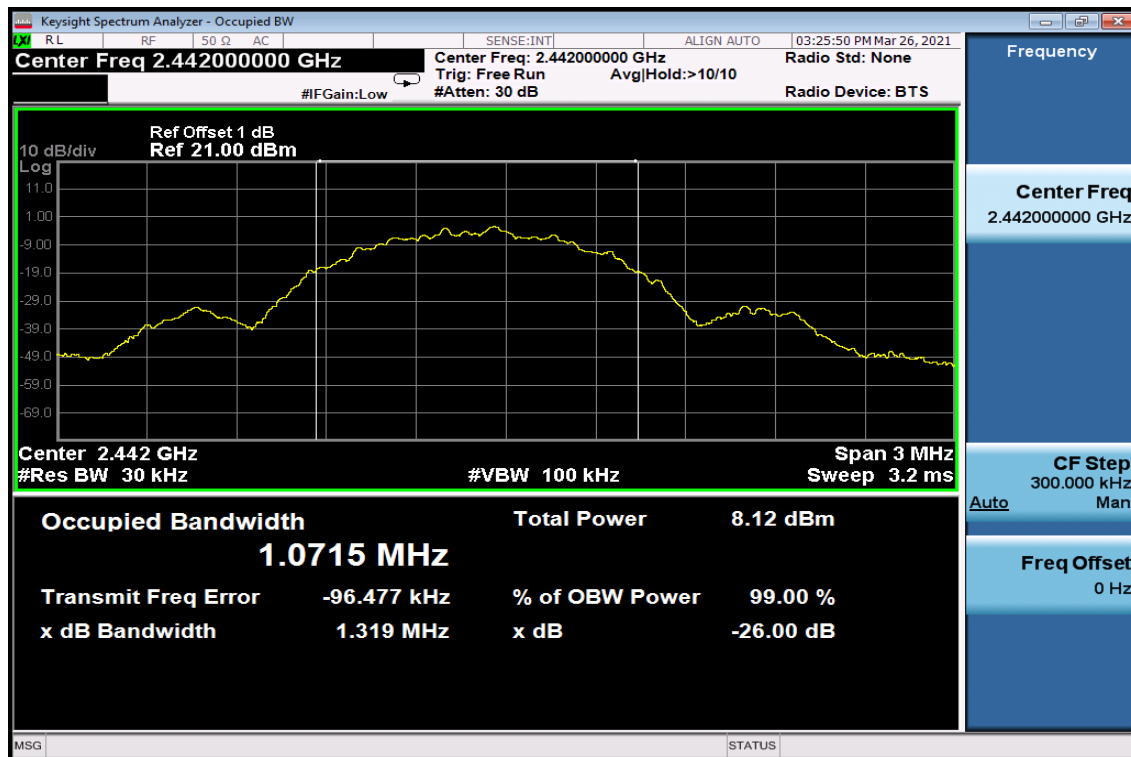

### 99% Bandwidth Test Data CH-Low

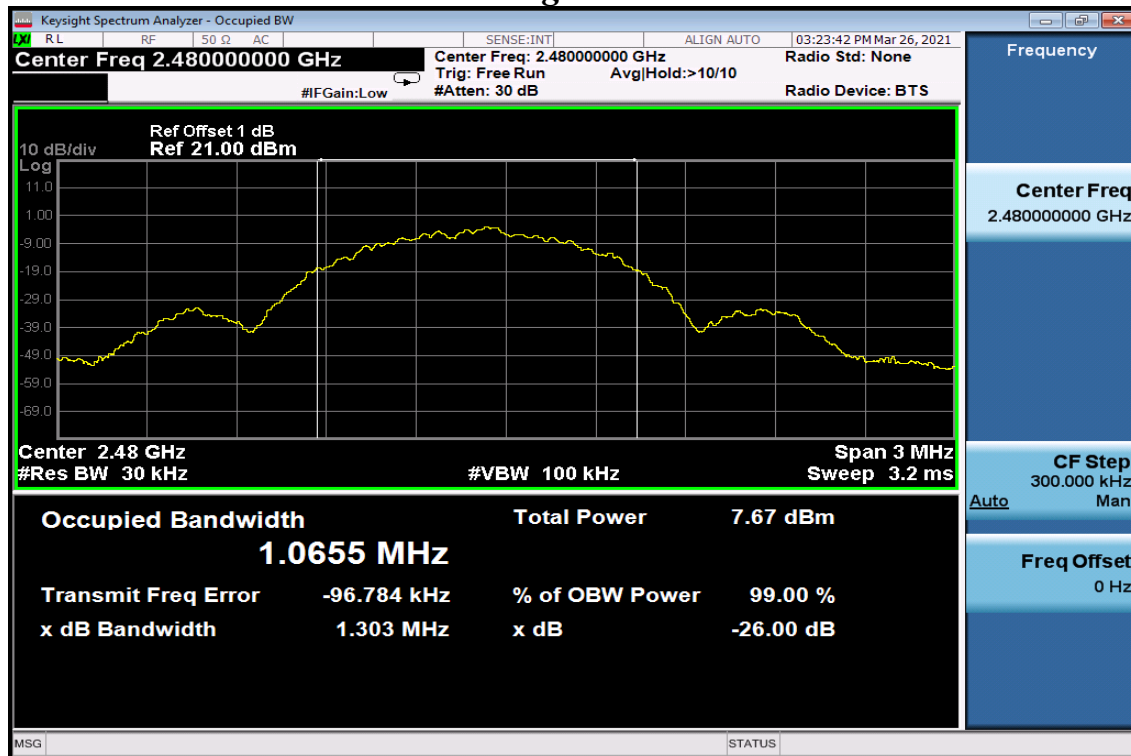




### 99% Band Width Test Data CH-Mid

## **8 Spurious Emission Test**

### **8.1 Standard Applicable**

According to §15.247(c), all other emissions outside these bands shall not exceed the general radiated emission limits specified in §15.209(a). And according to §15.33(a)(1), for an intentional radiator operates below 10GHz, the frequency range of measurements: to the tenth harmonic of the highest fundamental frequency or to 40GHz, whichever is lower.

According to RSS-247 issue 2, §5.5

In any 100 kHz bandwidth outside the frequency band in which the spread spectrum or digitally modulated device is operating, the RF power that is produced shall be at least 20 dB below that in the 100 kHz bandwidth within the band that contains the highest level of the de-sired power, based on either an RF conducted or a radiated measurement, provided that the transmitter demonstrates compliance with the peak conducted power limits. If the transmitter complies with the conducted power limits based on the use of root-mean-square averaging over a time interval, as permitted under Section 5.4(4), the attenuation required shall be 30 dB instead of 20 dB. Attenuation below the general field strength limits specified in RSS-Gen is not required.

#### 8.4 Measurement Procedure:

1. The EUT was placed on a turn table which is 0.8m above ground plane.
2. The turn table shall rotate 360 degrees to determine the position of maximum emission level.
3. EUT is set 3m away from the receiving antenna which varied from 1m to 4m to find out the highest emissions.
4. When measurement procedures for electric field radiated emissions above 1 GHz the EUT measurement is to be made “while keeping the antenna in the ‘cone of radiation’ from that area and pointed at the area both in azimuth and elevation, with polarization oriented for maximum response.” is still within the 3dB illumination BW of the measurement antenna.
5. Maximum procedure was performed on the six highest emissions to ensure EUT compliance.
6. And also, each emission was to be maximized by changing the polarization of receiving antenna both horizontal and vertical.
7. Repeat above procedures until all frequency measured were complete.

## **9 100kHz Bandwidth of Band Edges Measurement**

### **9.1 Standard Applicable:**

According to §15.247(c), in any 100 kHz bandwidth outside the frequency bands in which the spread spectrum intentional radiator is operating, the radio frequency power that is produced by the intentional radiator shall be at least 20dB below that in the 100kHz bandwidth within the band that contains the highest level of the desired power. In addition, radiated emissions which fall in the restricted bands, as defined in §15.205(a), must also comply with the radiated emission limits specified in §15.209(a).

According to RSS-247 issue 2, §5.5

In any 100 kHz bandwidth outside the frequency band in which the spread spectrum or digitally modulated device is operating, the RF power that is produced shall be at least 20 dB below that in the 100 kHz bandwidth within the band that contains the highest level of the desired power, based on either an RF conducted or a radiated measurement, provided that the transmitter demonstrates compliance with the peak conducted power limits. If the transmitter complies with the conducted power limits based on the use of root-mean-square averaging over a time interval, as permitted under Section 5.4(4), the attenuation required shall be 30 dB instead of 20 dB attenuation below the general field strength limits specified in RSS-Gen is not required.

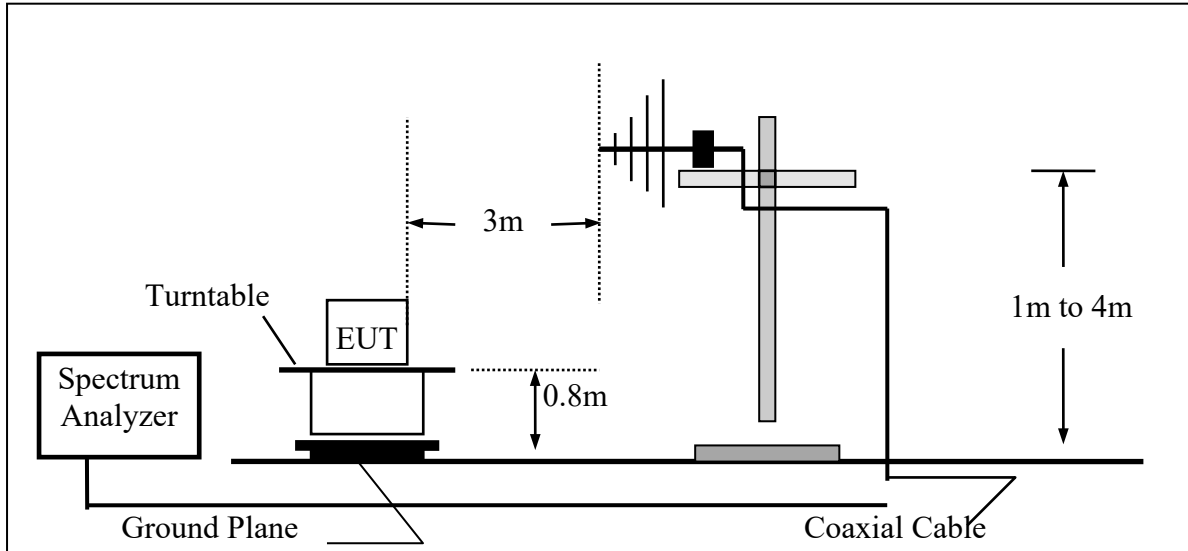

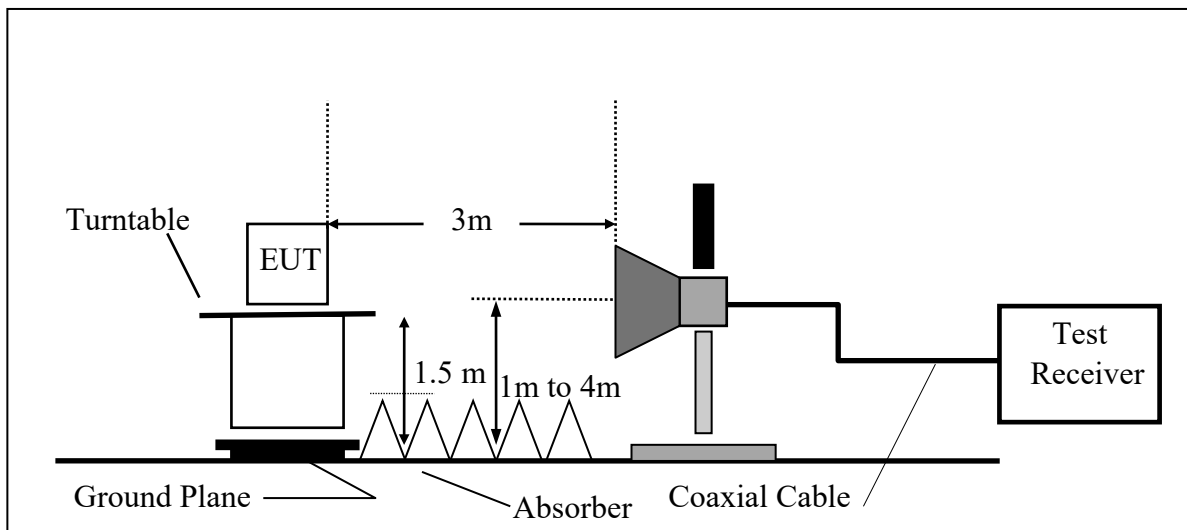

## 10 Peak Power Spectral Density

### 10.1 Standard Applicable:

According to §15.247(e) For digitally modulated systems, the power spectral density conducted from the intentional radiator to the antenna shall not be greater than 8 dBm in any 3 kHz band during any time interval of continuous transmission. This power spectral density shall be determined in accordance with the provisions of paragraph (b) of this section. The same method of determining the conducted output power shall be used to determine the power spectral density.

According to RSS-247 issue 2, §5.2

(2)The transmitter power spectral density conducted from the transmitter to the antenna shall not be greater than 8 dBm in any 3 kHz band during any time interval of continuous transmission. This power spectral density shall be determined in accordance with the provisions of Section 5.4(4), (i.e. the power spectral density shall be determined using the same method as is used to determine the conducted output power).

- i) Use the peak marker function to determine the maximum amplitude level within the RBW.

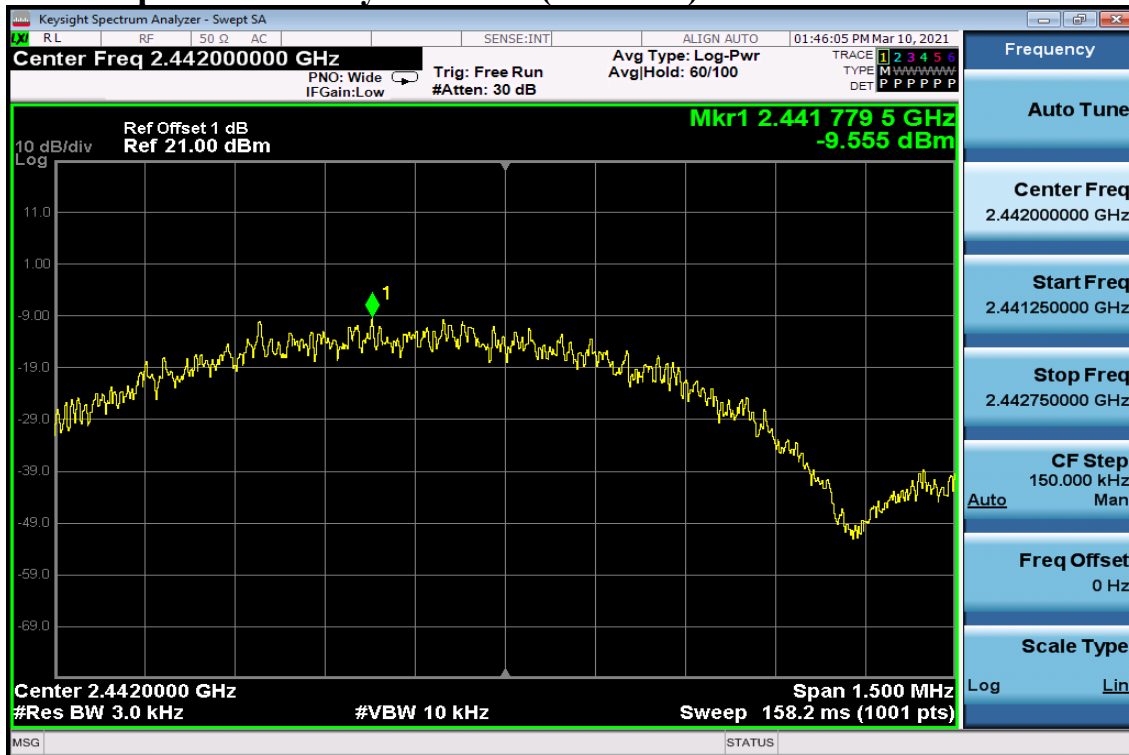

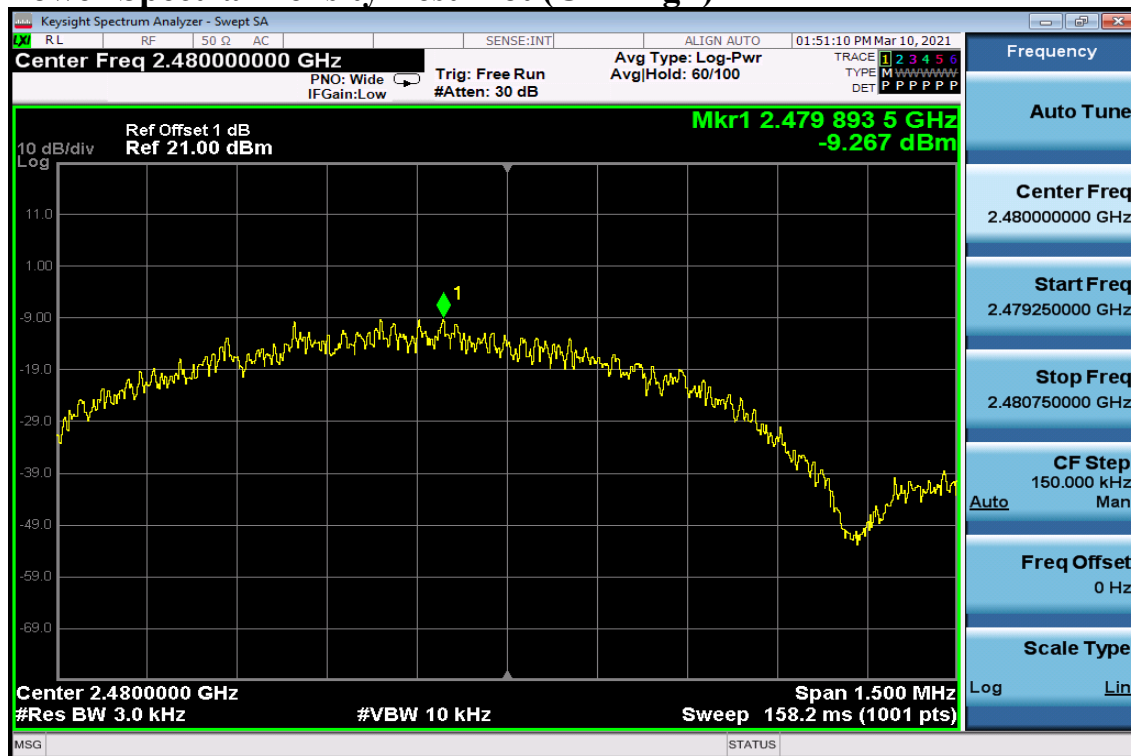

## 11 Antenna Requirement

### 11.1 Standard Applicable:

According to §15.203, Antenna requirement.

An intentional radiator shall be designed to ensure that no antenna other than that furnished by the responsible party shall be used with the device. The use of a permanently attached antenna or of an antenna that uses a unique coupling to the intentional radiator shall be considered sufficient to comply with the provisions of this Section. The manufacturer may design the unit so that a broken antenna can be replaced by the user, but the use of a standard antenna jack or electrical connector is prohibited. This requirement does not apply to carrier current devices or to devices operated under the provisions of Sections 15.211, 15.213, 15.217, 15.219, or 15.221. Further, this requirement does not apply to intentional radiators that must be professionally installed, such as perimeter protection systems and some field disturbance sensors, or to other intentional radiators which, in accordance with Section 15.31(d), must be measured at the installation site. However, the installer shall be responsible for ensuring that the proper antenna is employed so that the limits in this Part are not exceeded.

According to RSS-GEN 6.8 antenna requirement: The applicant for equipment certification shall provide a list of all antenna types that may be used with the transmitter, where applicable (i.e. for transmitters with detachable antenna), indicating the maximum permissible antenna gain (in dBi) and the required impedance for each antenna.

The test report shall demonstrate the compliance of the transmitter with the limit for maximum equivalent isotropically radiated power (e.i.r.p.) specified in the applicable RSS, when the transmitter is equipped with any antenna type, selected from this list.

For expediting the testing, measurements may be performed using only the antenna with highest gain of each combination of transmitter and antenna type, with the transmitter output power set at the maximum level. However, the transmitter shall comply with the applicable requirements under all operational conditions and when in combination with any type of antenna from the list provided in the test report (and in the notice to be included in the user manual, provided below). When measurements at the antenna port are used to determine the RF output power, the effective gain of the device's antenna shall be stated, based on a measurement or on data from the antenna's manufacturer.

The test report shall state the RF power, output power setting and spurious emission measurements with each antenna type that is used with the transmitter being tested.

For licence-exempt equipment with detachable antennas, the user manual shall also contain the following notice in a conspicuous location:

This radio transmitter [enter the device's ISSED certification number] has been approved by Innovation, Science and Economic Development Canada to operate with the antenna types listed below, with the maximum permissible gain indicated. Antenna types not included in this list that have a gain greater than the maximum gain indicated for any type listed are strictly prohibited for use with this device.

Immediately following the above notice, the manufacturer shall provide a list of all antenna types which can be used with the transmitter, indicating the maximum permissible antenna gain (in dBi) and the required impedance for each antenna type.

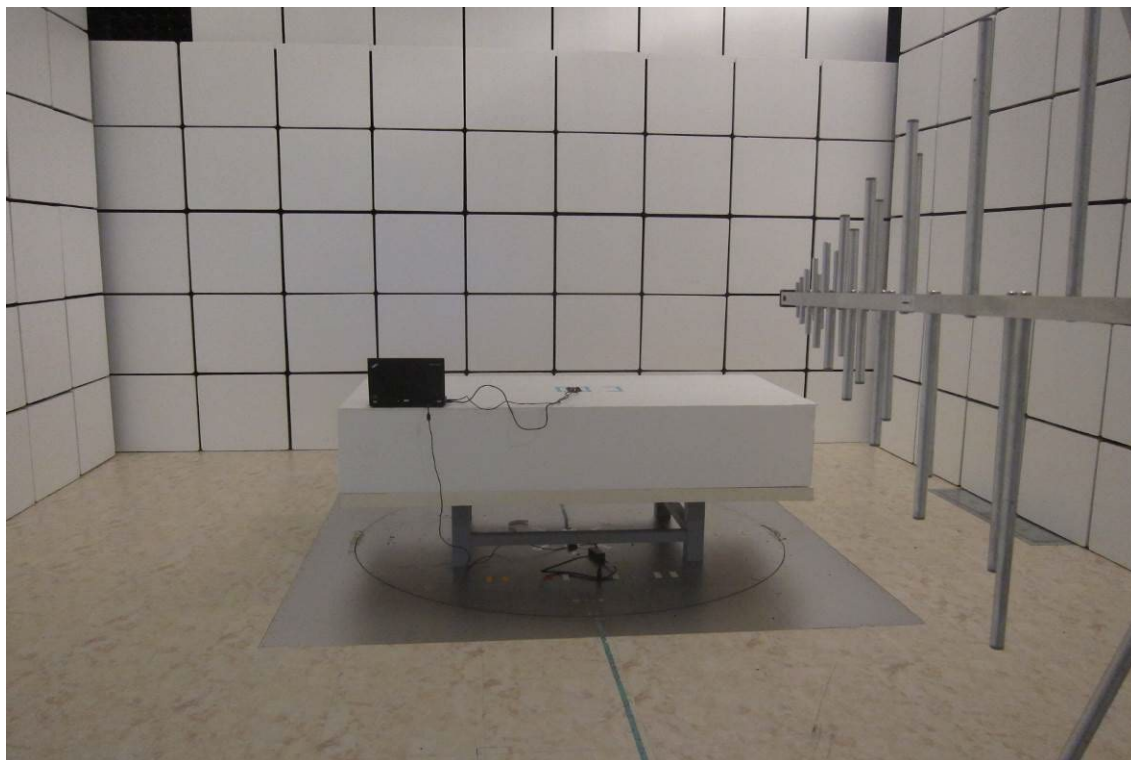

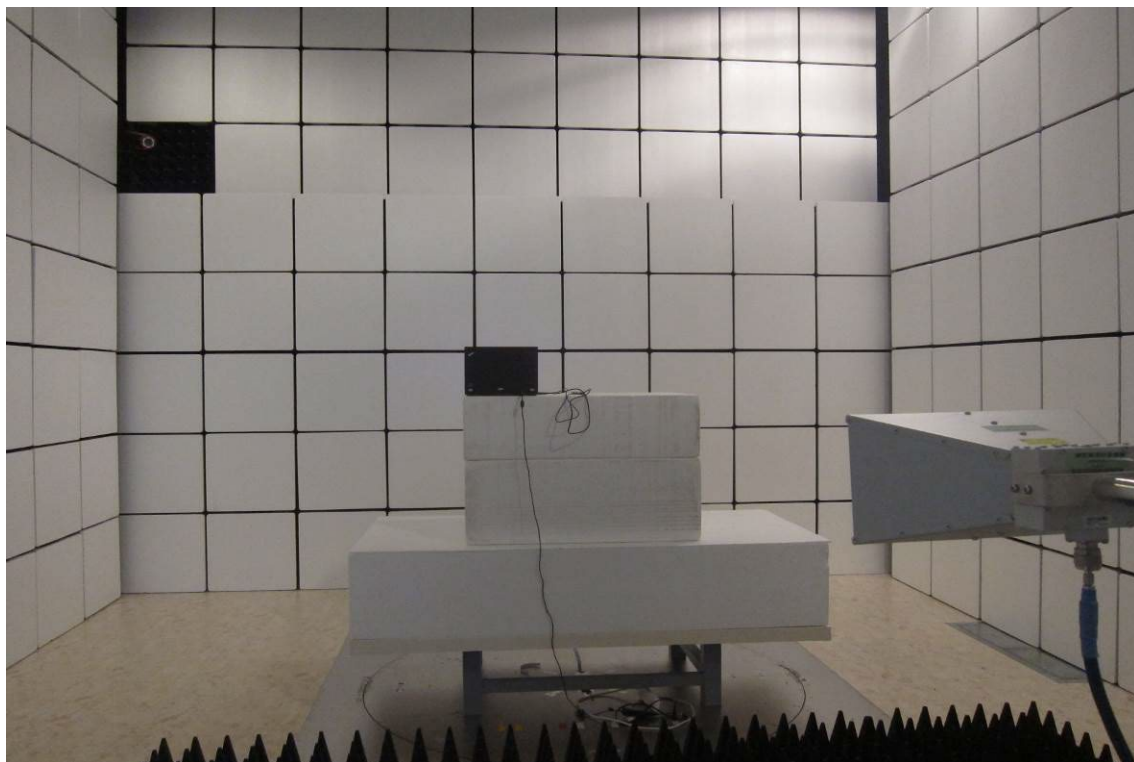
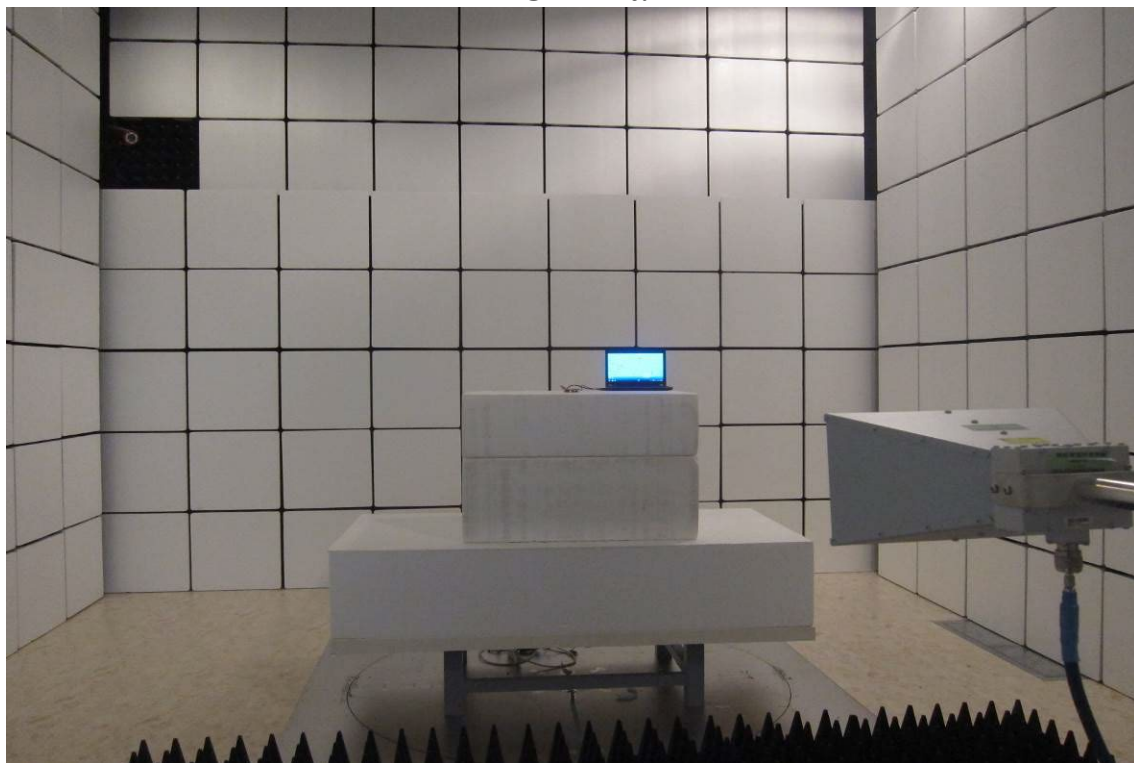


**Radiated Emission Setup Photos (below 1G)  
Dipole Ant.**

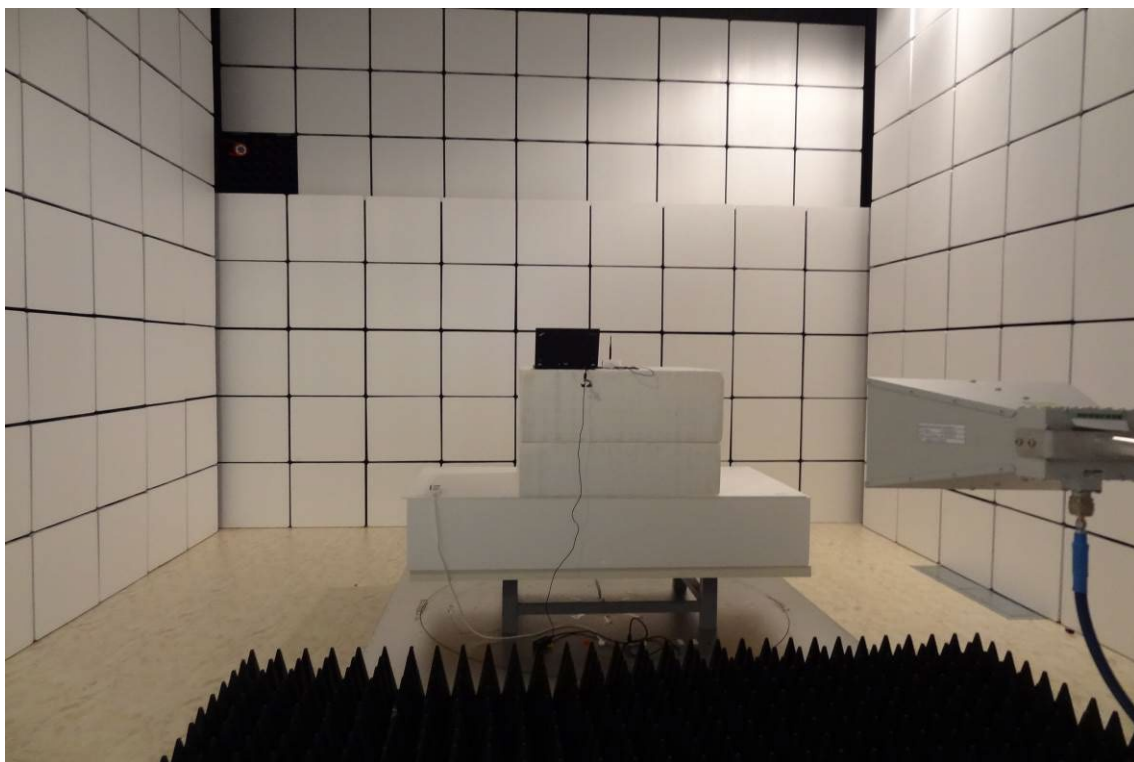
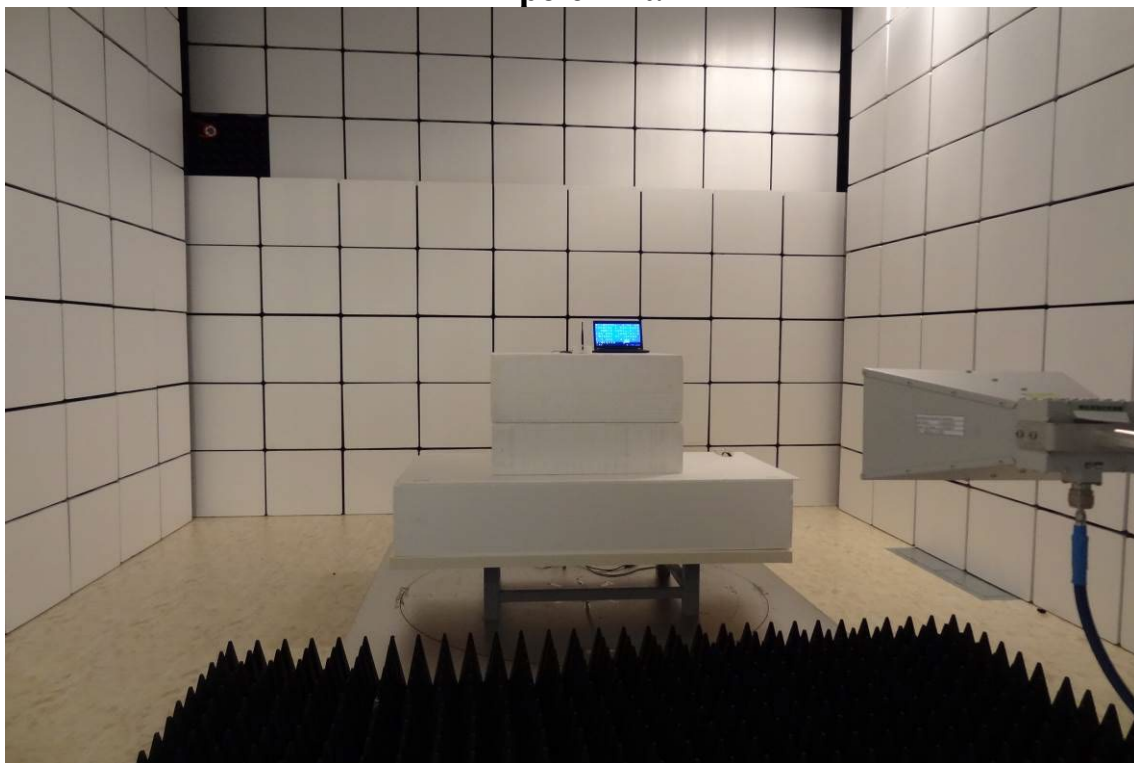

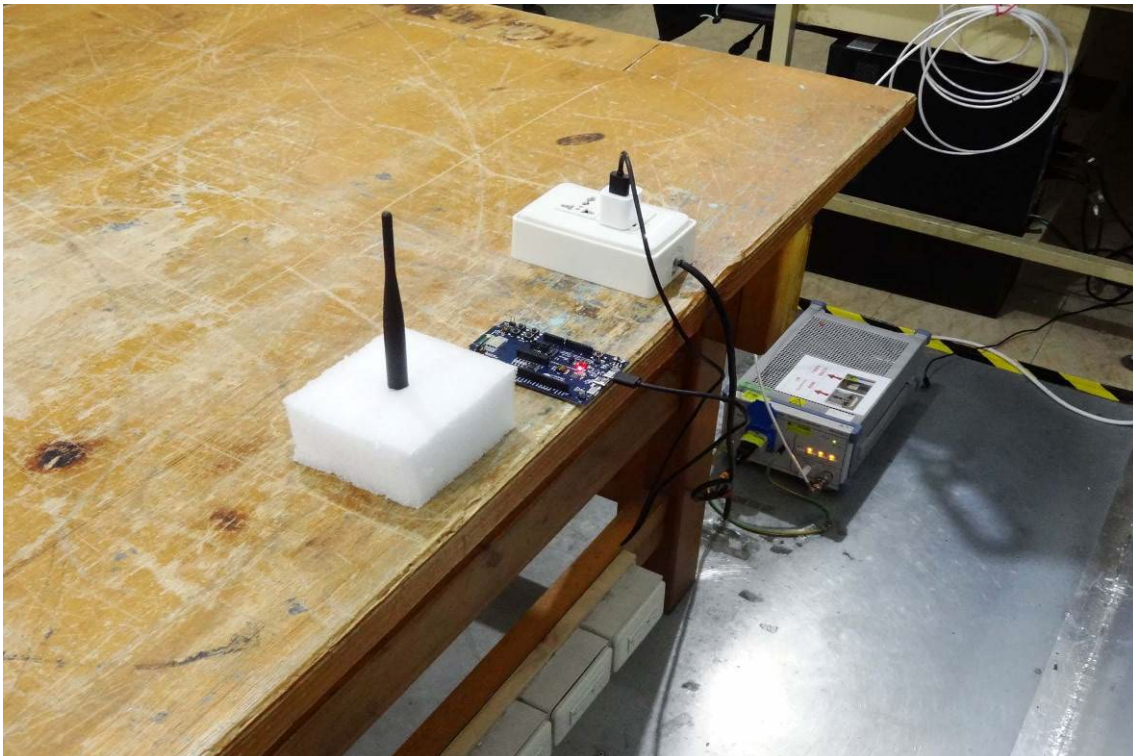
